- 4) Same tender was published on EPADS vide reference No: F-26031780574, published date 16-3-2026 & Closing date 7-4-2026.
- 4) That we (Expert Contracting) were declared technically qualified for further financial evaluation.
- 5) That We(Expert Contracting) are the lowest bidder in financial evaluation. Where as 2nd lowest bid was PKR.10.418M higher than us (F-26031780574).
